



**Proposed Landfill 7**

**Siting Plan**

- Current soil borrow area
- Further from neighbors
- 14 acres inside perimeter
- Avoids streams and wetlands

**Disposal Operations**

- Similar types of waste and treatment as Landfill 6
- Same volumes as currently approved
- Hazardous and residual waste
- Phased opening of sections
- To open as Landfill 6 closes

**Transportation**

- Same access routes to facility
- Same truck traffic limit
- Same driver training and emergency response program

**Estimated Economic Benefits (10-14 Year Life of Landfill)**

- Jobs, Pay and Taxes - \$20MM - \$25MM
- Local Goods and Services - > \$2MM
- Benefit Fees - > \$1.5MM to South Huntingdon Township
- Community Civic and Environmental Organizations - > \$1MM
- PA Fees Generated - \$20MM - \$30MM

**Application Process**

**Public Participation Opportunities**

**PRE-APPLICATION MEETING**

The applicant determines if the proposed landfill location is suitable, and if so, meets with DEP and local officials to discuss plans and visit the site.

- Informal public availability session hosted by MAX
- Pre-application site meeting with DEP attended by Westmoreland County and South Huntingdon Township
- Information repositories created for public review of information
- Comments accepted by DEP anytime
- Inquiries and mailing list requests met by MAX

**PHASE I APPLICATION**

The applicant submits the first phase of the application to demonstrate that the proposed location meets all minimum protection standards

- Public meeting and public hearing hosted by DEP
- Information repositories open for review
- Comments accepted by DEP anytime
- Inquiries and mailing list requests met by MAX

**PHASE II APPLICATION**

If the Phase I application is approved, the applicant prepares a Phase II application detailing proposed construction and operation of the landfill.

- Formal public meeting hosted by MAX before application is submitted
- Information repositories open for review
- Comments accepted by DEP anytime
- Inquiries and mailing list requests met by MAX
- Optional public meeting hosted by DEP

**PERMIT DECISION**

DEP prepares a draft decision on the Phase II application and provides an opportunity for the applicant and the public to respond before finalizing a decision.

- 45-day official public comment period beginning when draft decision is announced
- Optional public meeting hosted by DEP
- Information repositories open for review
- Inquiries and mailing list requests met by MAX
